

Mediware Customer Conference Call for Abstracts

INTERACTIVE PRESENTATION

The format of the Interactive Panel Presentation (IPP) Session allows for a 45-minute presentation involving a maximum of 25 PowerPoint slides per presentation. Materials should summarize content relevant to innovators in the post-acute, acute or community care setting, followed by a 10-minute Q&A session. This type of presentation provides the audience with rapid and intensive overview of content and allows for more in-depth discussion among presenters with their audience.

ABSTRACT INFORMATION

Submissions should follow the abstract format on page 2. Abstracts that do not conform to these requirements will be rejected without review. Submission will be electronic. The only accepted format for submitted papers is Adobe PDF. The abstract must be submitted no later than 5 p.m. US Eastern time June 29, 2018. Abstracts submitted after that time will not be reviewed. REQUIREMENTS

Abstracts related to research should describe original work; they should emphasize completed work rather than intended work, and should indicate clearly the state of completion of the reported results. Wherever appropriate, concrete evaluation results should be included.

Submissions will be judged on originality, technical strength, significance and relevance to the conference attendees in post-acute, acute and community care, and interest to the attendees. An abstract accepted for presentation at CareForum 2018, the Mediware and Kinnser Customer Conference may have been presented at other meetings or proceedings. You are eligible to give a presentation or participate in other capacities in the program provided you are registered for the meeting.

REVIEW PROCESS

The reviewing of the abstracts will be blind. Reviewing will be managed by the Conference Program Committee consisting of Co-Chairs and associated Program Committee Members. Final decisions on the technical program will be made by a meeting of the Program Co-Chairs and Committee Members. Each abstract submission will be reviewed by at least three program committee members.

MENTORING SERVICES

Mediware is providing a mentoring (coaching) service for presenters who require assistance in writing abstracts. A set of potential mentors will be identified by Bob Habasevich, who has agreed to organize this service for Mediware.
